Summary of key findings for parents

This provision is outstanding

- The childminder makes extremely good use of a wide variety of learning opportunities to help her to monitor the quality of her work. She has improved the setting since the last inspection and now ensures extremely high standards.
- The childminder makes meticulous and precise assessments of children's learning. She supports her assistant very effectively. This helps her to provide a seamlessly high quality of care and education for children.
- Children's emotional well-being is extremely strong. They have an excellent relationship with the childminder and are clearly very confident.
- Children make excellent progress and achieve outstandingly well. Children with special educational needs make very strong progress in their areas of need.
- The childminder has forged exceptional relationships with other professionals involved in children's care. She has an exemplary understanding of how sharing information with others helps to provide children with highly consistent care.
- Children have great fun in their learning as they play and are highly motivated to learn.

To further improve the quality of the early years provision the provider should:

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder has a detailed understanding of safeguarding issues and shares this with her assistant. They both know exactly what action to take should they have concerns about the welfare of a child. The childminder is highly effective at evaluating her provision and seeing how to make improvements. For example, she redesigned her outdoor play areas to maximise children's potential for outside learning. The childminder has achieved a very high standard in her professional expertise. One way she has achieved this is by creating resource packs from her training materials to develop her skills in assessing children's progress. The childminder has an excellent partnership with parents. For instance, both the childminder and parents add children's achievements to their records of learning as one way of sharing information.

Quality of teaching, learning and assessment is outstanding

The childminder has an exemplary understanding of how to promote children's learning and development through play. For example, the inspirational play environment motivates children to start highly challenging play ideas and to direct their own learning. The childminder supervises the work of her assistant extremely well to meet children's play needs. Children relish spontaneous opportunities to try new ideas. On occasion however, the childminder does not fully help older children develop their curiosity to see how things work. Their early writing, reading and number skills are developed brilliantly.

Personal development, behaviour and welfare are outstanding

Children's physical care and well-being are excellent. Children help prepare snacks and learn how to follow simple recipes, such as measuring milk, cutting fruit and whisking the mixture. Children benefit greatly from a wide variety of physical exercise, such as balancing, climbing and using ride-on toys. The childminder is very sensitive to children's care needs. For example, she gives young children special times to be quiet and enjoy exploring at their own pace. Children have highly mature skills in cooperative play. They spontaneously share their toys and find extra scoops and funnels so their friends can join in with filling bottles with sand to make skittles.

Outcomes for children are outstanding

Children make excellent progress in their learning and development. Children with special educational needs make strong progress in key skills. Children are extremely confident to try new activities, such as balancing, or reading stories while pretending to be the teacher. Children take great pleasure in showing their early writing skills. They put the letters of their name in order, and recognise their friends' names. Children acquire excellent skills in preparation for the next stage in their learning.
